In the present appeal, appellant as well as CPIO has mentioned RTI registration number as CICOM/R/2019/00008/CR-1, which is not correct. The correct RTI registration number against which present appeal filed is CICOM/R/2019/00007.

Decision with reasons:-

2. As per appeal, appellant is aggrieved with the reply of DR to CR-I on Point-4 of the RTI application. Appellant stated in the appeal that he received first Facilitation Memo No.157360 dated 19.09.2018 and after removing the deficiencies, he re-submitted the same on 08.10.2018, which was again returned vide Facilitation Memo No.161925 dated 12.10.2018 and he re-submitted it vide letter dated 29.10.2018. But the CPIO in his reply informed about the first FM No.157360 dated 19.09.2018. In this regard, the matter has been enquired from Shri Krishan Avtar Talwar, CPIO & DR to CR-I who informed that he supplied incomplete information and deeply regretted for the same. He further informed that after receipt of letter dated 29.10.2018, a second appeal was registered on 13.11.2018 vide No.CIC/DTGHS/A/2018/166352 and marked to the registry of IC(BJ), which will be listed for hearing by the concerned registry in its due course of time.


