## Brief facts of the case:-

In the RTI application, appellant has sought photocopy of reply submitted by Shri Vinod Giri, CPIO, Bombay office and Shri N.S. Ramu, Regional Manager, Chennai against the show cause notices in case File No.CIC/MA/C/2010/000102.

Shri K.L. Das, CPIO & DO to IC(BJ) vide letter dated 30.01.2018 responded as 2 under:-

"......In this connection it is informed that you have sought copy of explanation filed by Shri Vinod Giri (CPIO), Bombay and Sri N.S. Ramu, Regional Manager, Chennai, against the show-cause notices issued to them. Show-cause Notices are for penalty proceedings which is between the CIC and the erring CPIO. Even the complainant cannot claim audience, as a matter of right, in such proceedings, as held by the Division Bench of Delhi High Court in the matter of Ankur Mutreja Vs Delhi University LPC 764/2011 dated 09.11.2012. Further, no larger public interest has been demonstrated by you."

## Decision with reasons:-

On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that the CPIO has rightly denied providing information sought, in the light of Hon'ble High Court of Delhi order quoted by the CPIO, therefore, no intervention is required on the part of the FAA, in the matter.

- 4. The appeal is, therefore, disposed of.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
