Brief facts of the case:-

In the RTI application, appellant has sought 06 points information concerning to case F.No.CIC/RM/A/2012/001012, original file of which reportedly not available in the Commission as informed by Shri K.L. Das, CPIO in response to earlier RTI application of the appellant.

2. The public authority in the above mentioned case has since been transferred to the registry of IC(VN), therefore, Shri A.K. Assija, CPIO & DO to IC(VN) furnished the information as per record available in e-book of the concerned case file.

3. Aggrieved with the reply, appellant has filed present appeal.

Decision with reasons:-

In this connection, it has come to the notice of the FAA that case F.No.CIC/RM/A/2012/001012 was clubbed with case File No.CIC/DSELI/A/2018/185255 on the ground that the basic question involved in both the cases was the same and accordingly it was decided vide Commission's decision No.CIC/DSELI/A/2018/185255-BJ dated 01.01.2019.


