On perusal of the appeal, it is observed that the appellant has quoted wrong reference of CPIO's reply dated as 07.01.2019. The correct date of reply of the RTI application was 13.02.2019, which was given by Shri Krishan Avtar Talwar, CPIO & DR to CR-I and not by Shri R.P. Grover, CPIO. Hence, appellant is advised to take a note of it and in all future appeals, correct references be quoted.

Decision with reasons:-

2. On perusal of the RTI application, it is observed that the same information had already been sought by the appellant vide RTI application dated 15.05.2018, which was registered vide No.CICOM/R/2018/00539. An appeal dated 21.07.2018 was also filed by the appellant on the reply of the said RTI application, which was also disposed of vide FAA's decision No.CICOM/A/2018/00191 dated 09.08.2018.

3. It is not understood, why the appellant is seeking same information, which he already sought in his earlier RTI applications. Since the similar case already decided as mentioned in Para-2 above, no intervention is required.

4. In view of the above, the appeal is disposed of.


