**Brief facts of the Case:-**

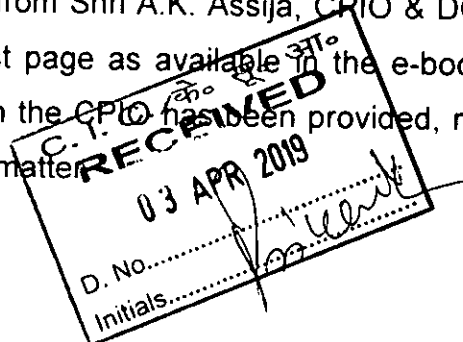
2. On Point 1, appellant has sought following information:-

*"1.Copy of the 'Page' of the 'Requester Letter' dated 05.11.2018 where 'Individual Remarks' given/signed by Sh. Piyush Agarwal on a 'Letter' addressed to Sh. Piyush Agarwal submitted by-hand in the Central Information Commission (CIC) vide Diary No.165978 on 05.11.2018 with Subject: Non-Compliance of the Hon'ble Commission's Order Passed under the RTI Act, 2005."*

3. As per appellant, copy of letter provided by the CPIO has no sign/markings of Shri Piyush Agarwal, Registrar or any other officer of the CIC and requested to order CPIO for providing correct information free of charge.

**Decision with reasons:-**

4. The matter has been enquired from Shri A.K. Assija, CPIO & DO to IC(VN) who informed that he provided copy of first page as available in the e-book. Since factual information as available on record with the CPIO has been provided, no intervention is required on the part of the FAA, in the matter.




