**Brief facts of the case:-**

In the RTI application, appellant has sought following information:-

*"Kindly furnish the details whether penalty has been imposed on delinquent official (Xerox copy enclosed)."*

2. Shri R.P. Grover, CPIO & DO to IC(YS) vide letter dated 26.02.2019 has furnished following information:-

*"1 As per record available in the appeal file no penalty has been imposed in the matter, as per record Hon'ble Information Commissioner has closed the file on 28.05.2018."*

3. In the appeal, appellant has stated that *"information is not provided"*.

**Decision with reasons:-**

4. On perusal of the appeal, it is observed that appellant himself enclosed a copy of aforementioned CPIO's reply dated 26.02.2019 with the appeal but alleging that information is not provided, which is not understood.
