**Brief facts of the case:-**

In the RTI application, appellant has sought 4 points information in respect of his two second appeals dated 09.01.2019 and 04.02.2019 filed in the Commission against SBI (Regional Manager), Ghaziabad and Meerut.

2. In the appeal, appellant has stated that

*"Please kindly strictly and mandatorily order to C.P.I.O. (public authority) concerned that do not willfully withhold easy and simple, disclosable, well-defined, well-exists and always possible information. Along with compensation & all expense occurred in filling RTI, First Appeal etc including cost of mental agony, harassment, precious time & valuable energy etc. etc. Avoid 2<sup>nd</sup> appeal unnecessarily.*

*CPIO with ill-intention, malafidely and illegally withhold the complete desired exists information as per Information Act-2005 rules and regulations & against the Indian legal laws. Due to refusal of my application in the time limit please arrange all attested/authorized documents/copies free of cost in a urgent manner."*

**Decision with reasons:-**

3. On perusal of the case file, it is observed that RTI application was received in the Commission 28.02.2019, received in the RTI Cell on 01.03.2019 and 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> being holidays registered in RTI-MIS software on 05.03.2019 and forwarded to Shri R. Sitarama Murthy, CPIO & DO to IC(SC) on 05.03.2018. Shri R. Sitarama Murthy, CPIO furnished the information vide letter dated 01.04.2019. Shri Murthy has furnished information on Points 3

& 4 of the RTI application and transferred Points 1 & 2 to CPIO & DR to CR-I for providing information directly to the applicant. On Points 3 & 4 CPIO & DO to IC(SC) replied that:-

*"Point 3 No such information like day to day status is available in the records.*

*Point 4 No letter sent."*

4. On Points 1 & 3 of the RTI application, Shri Krishan Avtar Talwar, CPIO & DR to CR-I vide letter dated 05.04.2019 has furnished following information, which is also found within the time:-

**"Point No. 1 & 2**

*Assistance was sought from the Incharge (Dak Section), custodian of the information. It has been intimated that your second appeal dated 09.01.2019 was diarized vide Dy.No.101810 on 08.02.2019. Software of the Commission reflects that on it a Second Appeal was registered vide No.CIC/SBIND/A/2019/105803 ON 27.02.2019.*

*These files will be listed for hearing in due course of time.*

**A copy of reply dated 05.04.2019 of Shri Talwar is enclosed herewith.**

5. From the above, it is clear that information furnished by both the CPIO is well within the prescribed period under RTI Act. Further, the information furnished by both the CPIOs is factual and appropriate. Since both 2<sup>nd</sup> appeals of the appellant have been registered in the Commission, appellant is advised to wait for the hearing of the said cases on their turn in due course of time.

6. The appeal is, therefore, disposed of.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
