Brief facts of the case:-

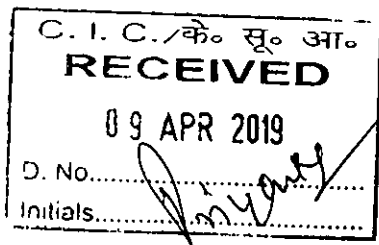
In the RTI application, appellant has sought registration number and present status of his 08 complaints/second appeals filed in the Commission.

2. On Point 1, appellant has stated in the appeal that CPIO has not provided complete information and on Points 2,3,4,6 & 7 CPIO has not provided case number against the diary numbers mention on these points.

Decision with reasons:-

3. On perusal of the RTI application, reply of the CPIOs' and appeal, it is observed that on Points 1 & 6, CPIO replied that no information is available in this registry about the action taken on Dy.No.168487 dated 28.09.2017 and Dy.No.114694 dated 08.03.2018.

4. On Point-2 & 7, CPIO in his reply informed that the diary numbers mentioned on these points are linked to the e-book of concerned case file Nos.CIC/UODEL/A/2016/298912/MP & CIC/RM/C/2012/000111/MP. Since the above diary numbers linked to the above said case file numbers, the submission of the appellant that no case file numbers are provided is not correct.



On Point-3 & 4, it has been confirmed by the registry of IC(DP) that Dy.No.115074 dated 09.03.2018, registered as 2nd Appeal vide No.CIC/CICOM/A/2018/115074 and Dy.No.115076 dated 09.03.2018, registered as 2nd Appeal vide No.CIC/CICOM/A/2018/115076 and hearing of both appeals already held on 02.04.2019.

6. From the above, it is observed that factual information has been provided by both CPIOs, therefore, no further intervention is required on the part of the FAA, in the matter.

7. The appeal is, therefore, disposed of.

8. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
