Appellant was earlier advised three times to file first appeal through online portal of DoPT i.e. <https://rtionline.gov.in/> or by post/hand, henceforth and if he still intends to file first appeal through email, he may ensure that appeal should invariably be signed otherwise that will not be entertained vide FAA's Orders No.CICOM/A/2019/00011 dated 15.01.2019, CICOM/A/2019/00028 dated 07.02.2019 and CICOM/A/2019/00036 dated 12.02.2019. But he once again sent present unsigned appeal through email dated 23.04.2019. However, in the spirit of RTI Act, it is being entertained but for the last time. Henceforth, no first appeal received through email from the appellant will be entertained.

**Brief facts of the case:-**

2. In the RTI application, appellant has sought following information in respect of case file No.CIC/CICOM/A/2017/175976/SD:-

*"Please refer to order dated 28.02.2019, passed by the Hon'ble Commission. I will be obliged, if, your good office provides, me information, containing 'certified copy' of the information provided by the Ld CPIO, as stated in the order dated 28.02.2019."*

3. In the appeal received through email, appellant has stated that:-

*".....it is incumbent upon 'public authority' to provide information within 'thirty days' whereas, in the present case information was not provided though mandatory period to provided information was already over on 10.04.2019, which attracts Section 20(1) of the RTI-Act-2005."*

**Decision with reasons:-**

4. The matter has been enquired from Shri H.P. Sen, CPIO & DO to IC(DP) who informed that he has already supplied the information vide letter dated 20.03.2019 A copy of the same, as provided by the CPIO is enclosed herewith.
