Brief facts of the case:-

In the RTI application, appellant has sought following information in respect of case File No.CIC/EICOI/A/2017/130640:-

- (i) *Copy of the enquiry report submitted by the Director, Export Inspection Council, New Delhi to the Commission.*
- (ii) *Action taken by the Commission, consequent to the receipt of the enquiry report."*

2. In response to RTI application, Shri A.K. Assijja, CPIO & DO to IC(VN) vide reply dated 25.04.2019 has furnished following information:-

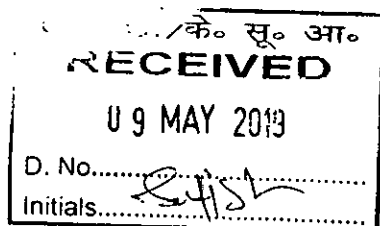
- (i) *A copy of the enquiry report No.RTI/2018-19/2395 dated 01.10.2018, received from the Assistant Director and CPIO, Export Inspection Council, in compliance of the CIC order in File No.CIC/EICOI/A/2017/130640 dated 16.07.2018 is enclosed.*
- (ii) *The enquiry report has been filed in the E-Book of above mentioned file."*

3. In the appeal, appellant has stated that no information was tendered in respect of point (ii) and requested to direct concerned CPIO to furnish complete information.

Decision with reasons:-

4. On perusal of the RTI application, CPIO's reply and appeal, it is observed that on Point (ii) of the RTI application, appellant has sought action taken by the Commission

after receipt of enquiry report but CPIO has not informed the action taken. **Direction is accordingly given to Shri A.K. Assija, CPIO & DO to IC(VN) to intimate the action taken, if any, to the appellant within 2 weeks from the date of receipt of the order.**

5. The appeal is disposed of.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
