**Brief facts of the case:-**

In the RTI application, appellant has sought following information in respect of Commission's order No.CIC/SD/C/2016/000014 dated 31.03.2017:-

*"A copy of withdrawal letter was presented before the commission by the CPIO, SOS Army Base Workshop, Delhi Cantt 110010. Please provide the copy of this withdrawal letter."*

2. Shri H.P. Sen, CPIO & DO to IC(DP) vide reply dated 30.04.2019 replied that *"the document sought by you is not available in the file."*
3. In the appeal, appellant has stated that *"Hon'ble CIC has quoted this Withdrawal letter in his decision (File No CIC/SD/C/2016/000014 dated 31/03/2017) and it must be available in office record file."*

**Decision with reasons:-**

4. To enquire into the matter, Shri H.P. Sen, CPIO has been called for who intimated that though the said 'withdrawal letter' was quoted in the said Commission's decision but no such withdrawal letter is found available in case File No.CIC/SD/C/2016/000014.

5. Since factual information has been provided by the CPIO, no further intervention is required on the part of the FAA, in the matter.


