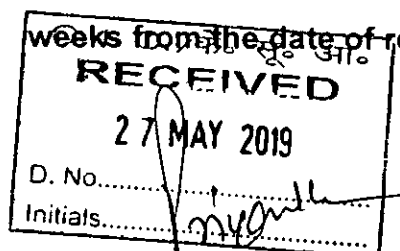
2. Shri R. Sitarama Murthy, CPIO & DO to IC(SC) vide letter dated 09.04.2019 replied that:


