
Brief facts of the case:-

In the RTI application, appellant has stated that:-

"Please refer to the enclosed copies of the following documents being self explanatory and for your kind perusal.

- 1 Copy of the Order of 21/3/2018 received from your end (with special reference to the underlined portion and the ticked marked address of C.I.S.F. on the reverse side of the said Order)
- 2 Copy of my letter of 16/8/2018 (with special reference to the ticked marked and underlined portions)
- 3 Copy of letter of 18/1/2019 receved from your end
- 4 Copy of my letter of 14/2/2019
- 5 Copy of my letter of 12/4/2019
- . 6 Copy of my letter of 11/5/2019
 - 7 Copy of letter of 20/5/2019 (clauses 2 and 3 ticked marked) received from your end

With reference to the said <u>Order received from your end</u>, my letter of 16/8/2018 and your letter of 20/5/2019 do you still advise me to pursue the matter with C.I.S.F. alongwith copy of the said Order <u>even when the needful has already</u> C. I. C. / 과 **been done by your end per the said Order** ? Please advise......."

2. Shri S.S. Rohilla, CPIO & DO to Chief IC vide letter dated 31.05.2019 replied that:-

"The information sought by you does not fall under section 2(f) of the RTI-Act-2005 as you have sought the advice of the CPIO."

Decision with reasons:-

3. On perusal of the submissions made in the appeal, it is observed that the appellant is not aggrieved from CPIO's reply but he is aggrieved with the non-compliance of Commission's order dated 21.03.2018 by the public authority 'CISF'. In this regard, if appellant so desires, she may file non-compliance of the Commission's order against the CPIO of the concerned public authority separately in the Commission.

4. The appeal is, therefore, disposed of.

5. In case the appellant is aggrieved by the decision, she is free to file second appeal, if she so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
