Brief facts of the case:-

In the RTI application, appellant has stated that:-

"The original appellant of the case No.CIC/AD/C/X/2009/000042 is my father and I was the appellant at the hearing on date 18.01.2019.

Kindly allow me an inspection of the record of the said case as per RTI procedure."

2. Shri TBJs Rajappa, CPIO, RTI Cell vide his reply dated 26.02.2019 responded that:-

"It is stated that the case number mentioned in letter appears to be not proper as MIS system of CIC is no record. Further action can only be taken at this end once proper number is made available."

3. In response to CPIO's above mentioned reply, appellant sent a letter dated 21.06.2019 along with copy of the CIC's decision dated 22.01.2019 and stated that:-

"With reference to your aforementioned letter (copy Annexed) it is clarified that the case no. is CIC/AD/C/X/2009/000042 titled "Krishan Kumar Saini Vs. The Mahanagar Telephone Nigam Limited."

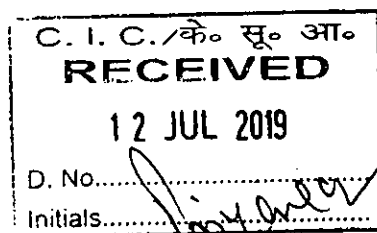
Kindly allow me inspection as per your said letter."

4. In reply to appellant's letter dated 21.06.2019, Shri TBJs Rajappa, CPIO, RTI Cell vide letter dated 27.06.2019 responded that:-

"In this regard, it is stated that your given file no.CIC/AD/C/X/2009/000042 is not correct. Therefore, it is not possible to provide you inspection."

5. Aggrieved with the response, appellant has filed present appeal.

Decision with reasons:-

6. On perusal of the AppsCom software, it is observed that soft copy of case No.CIC/AD/C/X/2009/000042 is not found available though the same case file number is found mentioned in the decision, copy of which provided by the appellant. However, a soft copy of case file No.CIC/AD/C/2009/000042 is found available in the AppsCom software containing documents related to case file No.CIC/AD/C/X/2009/000042. The public authority in the said case is "MTNL", which is allocated to the Registry of Chief IC.

7. In view of the above, **Shri S.S. Rohilla, CPIO & DR to Chief IC is directed to offer inspection of the above mentioned case file to the appellant with mutual convenient date and time within 2 weeks from the date of receipt of the order.**

8. The appeal is, therefore, disposed of.

9. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
