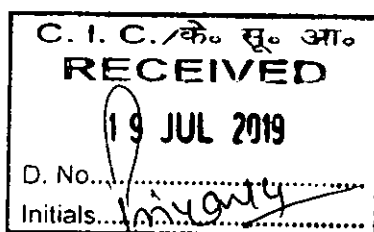
Brief facts of the case:-

In the RTI application, appellant has stated as under:-

"This is to say that I made an appeal to the Central Information Commission, the File No. of which was CIC/WB/A/2006/00811. The case was against Department of Science and Technology, Ministry of Science and Technology, Govt. of India. The case was heard by the First and Former Chief Central Information Commissioner Shri Wajahat Habibullah on 10th May, 2007. Another case against the same Department, having File No.CIC/WB/A/2006/00694 was also heard on the same day. (A copy of the decision dt. 10.05.2007, running in six pages, is enclosed).

Here I am reproducing the second paragraph of page 3 of the decision as aforesaid.

"This has reference to my (Vishwajeet Agrawal's) representation dated 10th January, 2005 to the Central Vigilance Commission (copy enclosed) regarding diversion of funds from NCMRWF Division of DST. I (Vishwajeet Agrawal) received an acknowledgement from CVC vide file No.005/SCT/001-2575 dated 09-02-2005 that my above cited letter has been forwarded to Vigilance Unif of this department (DST) for necessary action as given in the acknowledgement of CVC (copy enclosed)."

In this context, I would to have the following information/documents from the records of CIC (which are not traceable in my place), under Right to Information Act, 2005.

(1) A copy of my representation dated 10-01-2005 addressed to the Central Vigilance Commission (CVC) (which consists of one page).

(2) A copy of the letter/acknowledgement dated 09-02-2005 from the Central Vigilance Commission (CVC) (which consists of one page)."

2. Shri A.K. Assija, CPIO & DR to IC(VN) after taking assistance from Shri R.P. Singh, CPIO, Dak Section vide letter dated 27.06.2019 informed the appellant that "...software of the Commission does not reflect receipt of your representation dated 10.01.2008 to the Central Vigilance Commission and copy of letter/acknowledgement dated 09.02.2006 from Central Vigilance Commission."

3. In the appeal, appellant has reiterated the contents of his RTI application and CPIO's reply and requested to provide the documents as sought in the RTI application. He also requested for inspection of the concerned case files.


Decision with reasons:-

4. The appellant has quoted a para of page-3 of Commission's order No.CIC/WB/A/2006/00694 & 811 dated 10.05.2007, concerning to case file No.CIC/WB/A/2006/00811 in the RTI application and sought those two documents. It seems that the appellant had submitted these documents along with his 2nd appeal, registered in the Commission vide No.CIC/WB/A/2006/00811. The said documents might be available in the concerned case file, therefore, direction is hereby given to Shri R.P. Singh, CPIO cum I/c Record Room to search both case files, as both cases were decided in one order within two weeks from the date of receipt of this order and if available, the same be provided to Shri A.K. Assija, CPIO & DO to IC(VN) for furnishing information to the appellant and also offer inspection of case files to the appellant with mutual convenient date and time. In case, the said case files were weeded out being very old or otherwise, same may also be informed to the appellant.

5. The appeal is, therefore, disposed of.


6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.


