**Brief facts of the case:-**

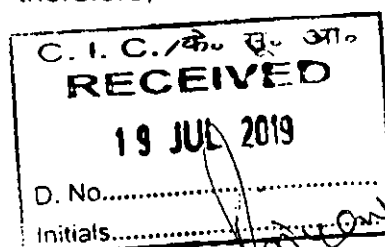
In the RTI application, appellant has sought ID/registration number, action taken by CIC so far and likely time of disposal of his 07 Second Appeals/Complaints, details of which are mentioned in the RTI application.

2. Aggrieved with the reply dated 03.07.2019 of Shri R.P. Grover, CPIO & DO to IC(YS), appellant filed the present appeal.

**Decision with reasons:-**

3. The submissions made in the appeal have been perused. Further on perusal of the records of RTI Cell, it is found that reply on Point-1 and Points 2 to 7 of the RTI application have also been furnished by Shri Rajesh Mongia, CPIO cum DR to CR-II and Shri Krishan Avtar Talwar, CPIO cum DR to CR-I respectively. A copy of reply dated 08.07.2019 and 09.07.2019 of the CPIOs are enclosed.

4. From the perusal of RTI application and replies furnished by the CPIOs, it is observed that point-wise information furnished by them is factual and appropriate, therefore, no intervention is required on the part of the FAA, in the matter.


