Brief facts of the case:-

4. As respondent failed to furnish reply/response yet in compliance of the Main order no.CIC/NDMCL/C/2016/302509 clubbed with the CIC/YA/C/2016/000231 dated 06/07/2018 of the Commission, please provide copy of action taken under provisions for violation of the RTI Act by the Commission.

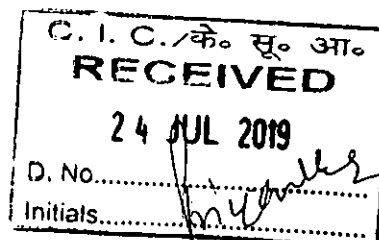
5. As Dy. Commissioner, Sh. Jagdish Chillar failed to furnish explanation yet in compliance of the Main order no.CIC/KY/A/2016/000559 clubbed with the CIC/YA/C/2016/000231 dated 06/07/2018 of the Commission, please provide copy of action taken under provisions for violation of the RTI Act by the Commission."

2. Shri R.P. Grover, CPIO & DO to IC(YS) vide letter dated 24.06.2019 has furnished following information on Points 3, 4 & 5:-

"3. Date of decision ie 06.07.2018 reported in the RTI seems to be wrong.

Decision with reasons:-

3. 

5. The appeal is, therefore, disposed of.
