
## Brief facts of the case:-

In the RTI application, appellant has sought following information:-

- "1. Provisions of RTI Law disclosed related to the 1 (one) RTI request & then 1(One) 1<sup>st</sup> Appeal are required.
- 2. Copies of the suo motu discloser of information of the Central Information Commission related to the u/s 4(1)(c)&(d) of the RTI Act-2005 as per u/s-4(4) of the RTI Act-2005 are required."
- 2. Shri TBJS Rajappa, CPIO, RTI Cell vide his reply dated 04.07.2019 has stated that "You may refer to RTI Act, 2005 & RTI Rules 2012 which are already available in public domain. You may go through the RTI Act, 2005 & RTI Rules, 2012". He also provided path for locating RTI Act & RTI Rules available in the Commission's website.

## Decision with reasons:-

3. On perusal of the RTI application, CPIO's reply and appeal, it is observed that CPIO, RTI Cell has provided information on Point-1 only, which is appropriate. On Point-2 of the RTI application, appellant has sought copies of suo motu disclosure of information of the Central Information Commission. In this regard, Shri TBJS Rajappa,

CPIO RTI Cell has been called for who informed that the suo motu disclosure of information in respect of Central Information Commission u/s 4 of the RTI Act is also available in the CIC's website i.e. <a href="https://www.cic.gov.in">www.cic.gov.in</a>.
