
1. The RTI application dated 24/06/2019, filed by Appellant Sh. Sushil Kumar, reply of Sh. R.P. Grover, CPIO dated 29/07/2019 as well as the First Appeal dated 30/07/2019 filed by Appellant were perused by the undersigned.
2. During hearing of the Appeal, the Appellant again made a similar request that he has not been informed the action taken on his letter dated 01/06/2019 and the CPIO has also not provided the documents as sought by the Appellant vide his above mentioned RTI application.
3. I have also gone through the reply dated 29/07/2019 sent by Sh. R. P. Grover, CPIO to the Appellant mentioning therein that the action on the letter dated 01/06/2019 of the Appellant is still pending. Entire information cannot be provided as per the decision of the Madras High Court in W.P. No. 26781/2013 and M.P. No. 1/2013 titled as Registrar Vs CIC, New Delhi. However, the Appellant was given an opportunity to inspect the



records and identify the copies of the documents to be provided to him. The same will be provided to him on payment of Rs. 2 per page.

4. The Appellant, during the hearing again pleaded that it is not possible for him to inspect the records and requested to provide him the copies of the documents which can be provided under the RTI Act, 2005 on payment of the requisite fee. He has further requested to inform him the present status of his case as requested by him vide his RTI application dated 01/06/2019. Sh. R.P. Grover, CPIO as also agreed to provide the same to the Appellant.
5. In view of the above, Sh. R.P. Grover, CPIO is hereby directed to revisit his reply dated 29/07/2019 and inform the Appellant the copies of the documents which can be made available to him on deposition of requisite fee with the Commission. He is also requested to provide him the latest status of the case of the Appellant pending with the Commission. CPIO is ordered to inform the Appellant accordingly within 15 days from the date of receipt of this Order.

Sh. Sushil Kumar is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.


