
**Record of proceedings:**

5. In view of this, there is no merit in the First Appeal filed by the Appellant and hence the same is dismissed.

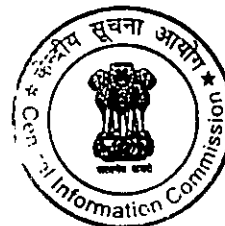
