Brief facts :

Sh. K.N. Surendran Pillai, the Appellant has sought the following information vide his RTI Application dated 13/07/2019:

1. Provide certified copies of:
 - i. File notings
 - ii. Internal external memos
 - iii. Correspondence generated,-inward, and outward- in respect of the application dated 01/02/2019.
 - iv. Present status of CIC/SBIND/A/2018/150342/13-8-2018
2. Sh. R. Sitarama Murthy, CPIO (IC-SC) replied to the above mentioned RTI application of the Appellant vide his letter dated 21/08/2019, mentioning therein :
 - i. Point no. 4 (a) (i) & (ii) : Certified copy of the file noting and memo is enclosed.
 - ii. Point no. 4(b) : Second Appeals filed and registered in January, 2018 are being heard. Your case, registered in 2019, will be heard by the CIC as per its chronological seniority.
3. Sh. K.N. Surendran Pillai, the Appellant being dissatisfied with the reply of the CPIO, filed a First Appeal dated 20/08/2019 before the undersigned and made the following grounds for Appeal:
 - i. The CPIO, Mr. Sitarama Murthy, in collusion and connivance with the habitual Bank fraudsters at the State Bank of India, M G Road Branch, Mumbai, deliberately hid and concealed the RTI application dated 13/07/2019 filed with the CIC office, Munirka, New Delhi.



- ii. Not provided information under RTI Act, 2005. The CPIO has sent a personal letter dated 02/08/2009 to the Applicant.
- iii. CPIO, abused his posting at the CIC office, New Delhi.
- iv. CPIO, made mockery of the Law enacted under – Right to Information Act, 2005.


Hence the First Appeal.

Decision :

On perusal of the RTI application dated 13/07/2019 filed by the Appellant Sh. K.N. Surendran Pillai, the reply of the CPIO Sh. R. Sitaram Murthy dated 21/08/2019 and the First Appeal dated 20/08/2019 filed by the Appellant, the undersigned is in full agreement with the reply sent by the CPIO to the Appellant as the CPIO has provided the requisite information in his reply dated 21/08/2019.

2. Since, the Appeal of the Appellant Sh. K.N. Surendran Pillai is devoid of merits, the Appeal is hereby dismissed.

Sh. K.N. Surendran Pillai is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.


