**Brief facts:**


1. The Appellant, Sh. Agnivesh Gupta sought the following information vide his RTI application dated 12/06/2019:
  - a) Copy of complete documents in file, the RTI application, the First Appeal of Applicant, and other documents along with reply orders of PIO, the 1<sup>st</sup> Appellate etc. if any.
  - b) Copy of the Hearing Notices served on the Applicant, the respondent public authority, the Ministry of UD, along with acknowledgements of RPAD letter of CIC received, if any; also letter envelope copies of notice returned to CIC, if any.
  - c) Certified copy of the orders of CIC dated 17/06/2019.
2. Sh. K.L. Das, DR to IC (BJ) & concerned CPIO, vide his letter dated 09/07/2019 provided the documents and the information sought by the Appellant along with the certified copy of the CIC's Order.
3. The Appellant, being dissatisfied with the reply of the CPIO filed a First Appeal dated 12/08/2019 before the undersigned mentioning therein that he has not received any reply or information in response to his RTI application dated 12/06/2019.
4. I have gone through the entire record of this case available in the file and noticed that Sh. K. L. Das, CPIO had sent the information and the documents to the Appellant along with his letter dated 09/07/2019 but it appears that the same have not been received by the Appellant till the date of filing the Appeal.

**Decision:**

1. Sh. K.L. Das, CPIO is hereby directed to send another copy of the documents and information sought by the Appellant within a period of 30 days from the date of receipt of this order.
2. Hence, the Appeal is disposed off accordingly.



Sh. Agnivesh Gupta is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.


