Brief facts:

1. The Appellant, Sh. Nanak Singh filed a RTI application dated 20/09/2016 wherein he has requested for a copy of an order bearing no. CIC/SS/A/2011/000863 dated 30/06/2011 pronounced by the CIC.

2. As per the records available, Sh. V.K. Sharma, the then DO & CPIO to IC (SB) replied to the said RTI application vide his letter dated 18/11/2016 and provided him the copy of the order bearing no. CIC/SS/A/2011/000863.

3. The Appellant being dissatisfied with the reply sent by the CPIO, filed a First Appeal dated 29/11/2016 stating that the information sought was not provided to him. The above mentioned First Appeal filed by the Appellant was wrongly registered by the Registry of the Central Information Commission as a Second Appeal bearing No. CIC/CICOM/A/2017/188738/SD. The Hon'ble IC Sh. D.P. Sinha, disposed off the alleged Second Appeal vide his decision dated 24/07/2019 with the observation that the instant matter has been erroneously registered as a Second Appeal when the Appellant filed the instant case as a First Appeal with the First Appellate Authority of the CIC. The Hon'ble IC (DP) marked the copy of the order to the Registrar, CIC to take necessary action in the matter.

4. On receipt of the order from the office of the Hon'ble IC (DP), Sh. K.A. Talwar, the CPIO and the DR-CR(I) has registered it as a First Appeal and forwarded the same to the First Appellate Authority for adjudication.


5. After perusing the records available in the file, it has been noticed that the Appellant had asked for a copy of an order pronounced in 2011 and as per the record, the copy of the same had already been sent by the then CPIO (concerned). However, Sh. R.P. Singh, In-charge (Record Room), who is also the custodian of the old record, is directed to take further action in the matter and if the copy of the said order is available in the old records, the same may be sent to the Appellant.

6. Hence, the Appeal is disposed off accordingly.



Sh. Nanak Singh is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
