## Brief facts:

- 1. The Appellant, Sh. Sunil Kumar Soni, vide his RTI application dated 18/07/2019 sought the following information:
  - i. With reference to CIC/CPIO/2009/375 dated 16/04/2009, kindly arrange to provide copy of reply/disposal of 1<sup>st</sup> Appeal, filed by him on 19/05/2009 by Hon'ble FAA, CIC, New Delhi.
- 2. Sh. T.B.J.S. Rajappa, CPIO (RTI Cell) sent a reply vide his letter dated 17/08/2019 to the Appellant informing him that the information sought is not available with him.
- 3. Being dissatisfied with the reply of the CPIO, the Appellant filed a First Appeal before the First Appellate Authority on 19/08/2019 on the grounds that:
  - i. The CPIO had claimed that the information is not available with him, in casual, careless manner indeed.
  - ii. Scope of First Appeal and name of First Appellate Authority avoided by the CPIO, and various other issues raised by him in his First Appeal.
- 4. After going through the RTI application, reply of the CPIO and the First Appeal filed by the Appellant, it appears that vide RTI application dated 18/07/2019 the Appellant sought some information but the same are not available with the Commission as per the reply of the CPIO. However, in the First Appeal, the Appellant has mentioned the grounds of the First Appeal and the reliefs sought do not match with the information sought. Therefore, the case is not clear regarding the information sought by the Appellant.
- 5. Hence, the Appeal is dismissed being devoid of merits.

Sh. Sunil Kumar Soni is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
