Brief facts of the case:-

2. In the RTI application, Shri Himanshu Rana, the Appellant has sought information relating to Central Information Commission on various issues numbering 38 e.g. the total annual budget outlay, amount spent in construction of CIC building, total sanctioned strength of staff ; total number of regular staff, consultants, outsourced staff working as on 01.06.2019; total amount of money spent on items purchased through GEM software and total amount paid to all contractors engaged in outsourcing activities for 2018-19 etc.

Decision with reasons:-

3. I have gone through the RTI application and the reply submitted by the CPIO. I am in agreement with the replies given by the CPIO against all the queries except for query Nos.12,13 and 14. It has been enquired and found that the reply had been given based on the information as available on the files of the CPIOs.

However, against query Nos. 12,13 and 14, the replies are not satisfactory. Against query 12 of the RTI application regarding the availability of reply of RTIs and FAA's decision on CIC website, CPIO, RTI Cell is directed to give an appropriate reply as asked for.

Against query No.13 and 14, Shri S.K.Rabbani, DS(GA)&CPIO is directed to give appropriate information on employees of NBCC and NIC working in the Commission to the applicant within 10 days from the date of receipt of the order.

4. The appeal is, therefore, disposed of.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
