Brief facts of the case:-

 - 2. Reasons(s) of no response by Chief Executive Officer-cum-Appellate Authority, Cantonment Board Office, Garhi Dehradun Cantt-248003

In response to that, Shri H.P.Sen, DO to IC(DP) and CPIO had replied as para 2 above.

- 4. It is seen from the documents submitted by the Appellant that the information has been provided by Cantonment Board office, Dehradun vide letter No.VI/56/RTI/86 dated 12 April 2019.
- 5. As regards the reason of no response by the Chief Executive Officer/Appellate Authority, Cantonment Board Office, Dehradun it is stated that it is not part of information. It is seen that if the applicant had not received a proper reply either from the CPIO or the First Appellate Authority Cantonment Board, he should have filed Second Appeal before the Central Information Commission.
- 6. It is further stated that if the applicant is not satisfied with the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
