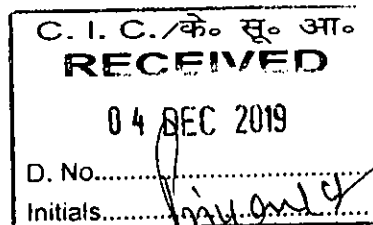

Brief facts of the case:-

In the RTI application, appellant has sought following information related to Appeal No. CIC/ADDDM/A/2017/173266:-

- Provide certified copies of the details of documents in connection with any fine/penalty imposed and disciplinary action taken against Shri Amit Pamasi (PIO), as mentioned in the above said decision in column Para No. 1 including explanation if any submitted by the said PIO on or before 11.08.2019 or not.
- Provide certified copies of the details of documents in connection with any fine / penalty imposed and disciplinary action taken against Shri Ashwini Kumar Mehta (PIO, as mentioned in the above said decision in column Para No. 2 including explanation if any submitted by the said PIO on or before 11.08.2019 or not.

2. In Appeal petition Appellant has mentioned that desired information has not been received so far and requested to provide the information and penalize the CPIO for violation of RTI Act, 2005.

Decision with reasons:-

3. On perusal of the RTI application, CPIO's reply and appeal, it is observed that the above mentioned RTI Application has been received in RTI Cell of the Central Information Commission on 16.09.2019 and the point wise information has been sent by Sh. R P Grover, CPIO & DO to IC (YS) vide letter dated 16.10.2019, thus this is not the case of violation of RTI Act. It is also observed that the information given by CPIO, Sh. R. P. Grover is factual and as available in record, therefore, no intervention is required on the part of the FAA, in the matter. The copy of information given by CPIO is attached with this order.

4. The appeal is, therefore, disposed of.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.


1. Expiation for total number of pages 22 received from Sh Amit Pamasi has been received vide dairy no 138236
