Brief facts of the case:-

In the RTI application, appellant has sought following information:-

"1. What is the process, procedure and inhouse mechanism followed by CIC in dealing with complaints received from citizens of India against Information Commissioners at CIC.

2. Was the laid down process and procedure followed with respect to my aforesaid two complaints sent to Chief Information Commissioner?

3. If the answer to Question No.2 is in the affirmative, then kindly provide me a certified copy of the file notings, steps taken and the procedure followed by CIC to deal with my complaint and a copy of feedback, if any given to ICs by the Chief Information Commissioner."

2. The Appellant is not satisfied with the reply of the CPIO as copy of complaint policy requested by him was not furnished nor is it available on the CIC Website. Further, the CPIO's reply is also silent with respect to the outcome of Appellant's complaint against the two ICs dated 02.06.2019 and 09.09.2019 sent to Chief Information Commissioner, CIC. Appellant also sought copy of feedback i.e. the file notings of the Chief Information Commissioner while disposing of his above two complaints.

3. On perusal of the RTI application, CPIO's reply and appeal, it is observed that CPIO, RTI Cell mentions against query No.1 that complaints against Information Commissioners are dealt under complaint policy of the Commission as per office order No.34/02/2016-CIC/ADMN dated 23.9.16 but copy of the said office order was not attached with the reply.

Accordingly, Shri T.B.J.S.Rajappa, CPIO is directed to provide a copy of the said office order to the Appellant with 10 days of the receipt of this order.

4. Against query No.3, the applicant has also asked the outcome of his two complaints dated 02.06.19 and 09.09.19 and also copy of feedback i.e. file notings of Chief Information Commissioner's Office. In this regard, CPIO is directed to obtain outcome and file notings of CIC Office, if any, and supply to the applicant within 10 days.

5. The appeal is, therefore, disposed of.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
