

#### Brief facts of the case:-

In the RTI application, Shri Mohan Lal Jain, Appellant sought information under RTI 2005 regarding compliance of Commission's decision CIC/SA/A/2015/000705 on 7 points. Appellant regretted that the information provided by Sh. R. P. Grover, CPIO is incomplete and factually incorrect stating that point 5 of the reply does not refer to the original RTI.

# Reply of CPIO:-

2. Sh. R. P. Grover, CPIO replied for point No. 1 to 7 in respect to above mentioned RTI application vide letter No. CICOM/R/2019/00757 dated 04.11.2019.

## Hearing of the Appeal

3. The Hearing Notice was issued for the matter on 18.12.2019 and the matter is heard on scheduled date and time, i.e. on 30.12.2019 by First Appellate Authority. During the hearing CPIO Sh. R. P. Grover and appellant Sh. Mohan Lal Jain, both were physically present.

#### Decision with reasons:-

4. On perusal of the Appeal, RTI application, CPIO's reply and submission of appellant and CPIOs during hearing, it is observed that point wise information has already been provided by CPIO Sh. R. P. Grover. It is also observed that reply for Point

- No. 1, 2, 3, 4, 6 and 7 is appropriate and factual, but reply for point No. 5 of RTI application is not satisfactory. Therefore CPIO, Sh. R. P. Grover was directed to provide fresh and factual reply to appellant for Point No. 5 after the hearing. In compliance of direction of FAA, CPIO Sh. R. P. Grover provided the fresh and factual information for Point No. 5 of the RTI application by evening of 30.12.2019 through email to the appellant and copy endorsed to First Appellate Authority.
- 5. The appeal is being disposed of accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
