Brief facts of the case:-

1. Shri Arun Kumar Sinha, Appellant vide his RTI application sought date wise action taken on his petitions dated 18.08.2018 and 11.01.2019 related to compliance of 2nd Appeal Order No. CIC/POSTS/A/2018/116032.

Reply of CPIO:-

2. Sh. A. K. Assija, CPIO provided the desired information on 06.11.2019 stating that petitions dated 18.08.2018 and 11.01.2019 mentioned in the RTI application are linked to the E-Book of the case. Further, a copy of letter dated 20.10.2019 issued by the Commission in connection with compliance of CIC order is attached.

Hearing of the Appeal

3. The Hearing Notice was issued for the matter on 19.12.2019 and the matter is heard on scheduled date and time, i.e. on 30.12.2019 by First Appellate Authority. During the hearing CPIOs, Sh. A. K. Assija and Sh. T. B. J. S. Rajappa were physically present while Appellant Sh. Arun Kumar Sinha was absent. As appellant was not present during hearing, so the decision is being issued on the basis of documents available in record.

Decision with reasons:-

- 4. On perusal of the Appeal, RTI application, CPIO's reply and submission of CPIO during hearing, it is observed that point wise information has already been provided by CPIO Sh. A. K. Assija. The reply given by the CPIO is as per the records available. Appellant has also stated in his appeal petition that CPIO has not sent attested annexure as demanded by Para 7 (7c) of the information petition. So direction is accordingly given to Sh. A. K. Assija, CPIO & DO to IC(VN) to provide a certified copy of the said letter to the appellant within 10 days of receipt of this order.
- 5. In the appeal petition, appellant has further mentioned that the name of the First Appellate Authority has not been mentioned in the CPIO reply. In this case CPIO mentioned that, since the incumbent holding charge of FAA in CIC was relieved from the CIC and the name of substitute FAA was yet to be finalised by CIC. the CPIO in the meanwhile thought it proper to send the reply without giving the name of FAA.
- 6. The appeal is being disposed of accordingly.
- 7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
