Brief facts of the case:-

1. Shri Ashit Kumar Bangal, Appellant vide his RTI application addressed to Ms. Vanaja N Sarna, Hon'ble Information Commissioner sought information as "why you did not penalize those four Govt Officials by deducting from their salary and to compensate me?"

Reply of CPIO:-

2. Sh. A. K. Assija, CPIO provided the desired information on 19.11.2019 stating that ***"the decision of the case vide file No. CIC/DOIPP/C/2017/139904 dated 19.02.2019, has been taken on the basis of merits of the case by the Information Commissioner. No information/record is available pertaining to the reason as to why penalty has not been imposed or with regard to grant of compensation to the appellant."***

Hearing of the Appeal

3. The Hearing Notice was issued for the matter on 19.12.2019 and the matter is heard on scheduled date and time, i.e. on 30.12.2019 by First Appellate Authority. During the hearing CPIOs, Sh. A. K. Assija and Sh. T. B. J. S. Rajappa were physically present while Appellant Sh. Ashit Kumar Bangal was absent. As appellant was not present during hearing, so the decision is being issued on the basis of documents available in record.

4. On perusal of the Appeal, RTI application, CPIO's reply and submission of CPIO during hearing, it is observed that the reply given by the CPIO is as per RTI Act, 2005, therefore no further intervention is required on the part of the FAA, in the matter.
