**Brief facts of the case:-**

1. Shri Sh. Yogesh Malhotra, Appellant vide his RTI application dated 04.11.2019 sought information as:

1. Kindly provide copy of registered maintained at the gate by the Guards i.e. containing the entry details of visitors dated 13.09.2019 in the building of Hon,ble Central Information Commission.
2. Kindly provide copy of registered maintained at the gate by the Guards i.e. containing the entry details of visitors vehicles, name of the visitor(s), who have parked the vehicle in the parking dated 13.09.2019 in the building of Hon,ble Central Information Commission.
3. Whether any charges for vehicle parking in the building of Hon,ble Central Information Commission? Kindly clarify in details.
4. Whether any token issued to the visitor(s) who have parked their vehicle(s) in the building of Hon,ble Central Information Commission? Kindly clarify in details.
5. Who can park their vehicle(s) in the building of Hon,ble Central Information Commission? Kindly clarify.
6. What are the formalities to park vehicle(s) in the building of Hon,ble Central Information Commission? Kindly clarify.

Reply of CPIO:-

2. The point wise information dated 11.12.2019 provided by Sh. S. K. Rabbani is as under:

- Point No. 1 & 2. The information cannot be provided as it is personal in nature and exempt from disclosure under section 8. 1 (j) of RTI Act, 2005.
- Point No. 3. There is no charges for parking of vehicle in Building of Central Information Commission.
- Point No. 4. No token is issued for parking the vehicle.
- Point No. 5. Visitors of CIC office can park the vehicle in visitors parking.
- Point No. 5. There is a separate gate for entry of vehicles for visitors. A Register is maintained at the visitors' gate for the entry of vehicles.

Ground of First Appeal:

3. Appellant has not received any reply from PIO.

Comments of CPIO:

4. For disposal of First Appeal written comments of CPIO were asked by FAA but no Comments received.

**Hearing of the Appeal:**

3. For disposal of the appeal, appellant has been contacted over Mobile No. 9810473991 provided by appellant in Appeal application and heard the matter.

Decision with reasons:-

5. On perusal of the Appeal, RTI application, CPIO's reply and telephonic discussion, it is observed that the information for point No. 1 & 2 provided by Sh. S. K. Rabbani is not satisfactory, therefore direction is given to Sh. S. K. Rabbani, CPIO to provide the desired information to the appellant within 10 days of receipt of this order.

However the information for point No. 3, 4, 5 and 6 provided by Sh. S. K. Rabbani, CPIO is factual, therefore no further intervention is required on the part of the FAA, in the matter.

5. The appeal is being disposed of accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
