- 3. Shri T.K. Mohapatra, CPIO & DO to ex. IC(SA) vide online reply dated 07.01.2019 has replied that:-

"You have asked for certified and signed copy of the letter send to Sh. Jai Prakash Supta signed by Sh. Dinesh Kumar, Deputy Registrar. It is to be mentioned that the signed letter of Sh. Dinesh Kumar, CPIO/Dy. Registrar had been sent to the RTI Applicant Sh. Jai Prakash Gupta. No other signed letter is available. Hence, it is not possible to provide you copy of the same as desired by you."

4. In the appeal, appellant has stated that:-

"FAA is requested to kindly order providing of unsigned but certified copy of the said letter, since the signed copy is not available. The appeal may also be disposed of on 10.01.2019 and certified copy may also be handed over on 10.01.2019."

Decision with reasons:-

- 4. During the hearing, appellant reiterated the same. However, appellant has been informed that signed copy of the aforementioned letter dated 28.07.2017 found in the record of the RTI Cell and Shri TBJS Rajappa, CPIO, RTI Cell has provided a certified copy of the same, which is enclosed herewith.
- 5. The appeal is, therefore, disposed off accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
