Record of proceedings

1. I have gone through the contents of the RTI application of the Appellant seeking information which are as under:
"Please supply me the name of all employees who are public servant as per Section 21 of IPC, which is attached. Specially kindly inform if Shri H.P. Sen is a public servant in terms of Section 21 of IPC."
2. Smt. Savita Taluja, CPIO & SO (Admin) informed the Appellant vide her letter dated 09/01/2019 that she is not required to furnish information which required drawing of inferences and to provide opinion in terms of Supreme Court order in – CBSI & Anr. Vs. Aditya Bandopadhyay & Ors., SLP (C) No. 7526/2009. As per record, Sh. H.P. Sen, a retired Govt. Servant has been engaged as Consultant on contract basis.
3. The Appellant made a Second Appeal on the ground that the CPIO refused access to the information requested.
4. I have gone through the entire material available on record and I do not agree that the attitude of the CPIO is to create hindrance in providing information and whatever information available with her was provided to the Appellant. The CPIO should have informed the Appellant whether the list of public servants in terms of IPC has been maintained by the Commission or not.
