

Record of proceedings

1. It has been noticed that the Appellant had sought the following information vide his application dated 25/12/2018 from the office of Sh. H.P. Sen, CPIO & DO to IC (DP):

"Sh. H.P. Sen, DO to IC (DP) is requested to offer inspection of register maintained for out of turn hearing."

- 2. It is further noticed that in response to the said RTI application, Sh. Sen informed the Appellant vide his letter dated 01/01/2019 that he may inspect the register any time after 3:00 p.m. on any working day.
- 3. The Appellant has filed a First Appeal mentioning therein that he sent an e-mail on 17/01/2019 to the CPIO that the Appellant will carry out inspection of register maintained by the concerned Registry of the Commission on 24/01/2019. The said fact was also informed by the CPIO on telephone. Accordingly, the Appellant visited the Commission and found that Sh. Sen was on leave that day and as such the inspection would not be possible as the CPIO did not entrust the responsibility to any other official to do the needful. The Appellant further mentioned that Sh. Sen did not have the courtesy to inform him that it would not be possible for inspection and the Appellant should have come another day so that the inconvenience caused could have been avoided.



- 4. The Appellant had requested the First Appellate Authority to order the CPIO to give confirmed date and time in consultation with the Appellant and also order to compensate the Appellant to the tune of Rs. 5400 for which a justification will be given by him at the time of hearing.
- 5. Having considered the facts and circumstances mentioned above, the CPIO is hereby directed to get the register inspected by the Appellant within a period of 15 days from the date of receipt of this order and he must get a confirmation of date and time of inspection from the Appellant. The request of the Appellant for ordering compensation of Rs. 5400 has no merits at all especially in view of the fact that the Appellant neither appeared before the undersigned on the date of hearing nor provided any justification of the said claim.

The above mentioned Appeal is disposed of accordingly.

Sh. Jasbir Singh Arora is further informed that he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
