Record of proceedings

1. The above mentioned 5 First Appeals have been filed by Sh. Jasbir Singh Arora, in respect of his RTI application bearing Nos. CICOM/R/2019/50026/4, CICOM/R/2019/50026/1, CICOM/R/2019/50026/2, CICOM/R/2019/50026/5 and CICOM/R/2019/50026/6 against non-furnishing of information/furnishing incomplete information by the respective CPIOs.
2. The above mentioned Appeals were fixed for hearing on 20/02/2019 at 11:30 a.m. and a notice of hearing was sent to the Appellant and all concerned CPIOs to attend the hearing on the stipulated date and time. Sh. Jasbir Singh Arora, neither attended the hearing nor sent any communication relating to his non-appearance. However, the CPIOs mentioned above had attended the hearing and made their submissions. It is also pertinent to mention that Sh. Arora had made his written submissions dated 10-02-2019 in support of his First Appeals which has been considered by the undersigned while disposal of the Appeals.

3. It has been noticed that the Appellant sought the following information vide his RTI application referred to above:

**"INFORMATION THUS REQUESTED IS CERTIFIED COPY OF DOCUMENTS GIVING THE LIST MAINTAINED BY ALL THE BENCHES OF CENTRAL INFORMATION COMMISSION ON NON COMPLIANCE PETITIONS/APPLICATIONS/COMPLAINTS ETC. AS THE SAME IS NOT AVAILABLE IN THE WEBSITE OF CENTRAL INFORMATION COMMISSION. ALSO PLEASE PROVIDE NUMBER OF NON COMPLAINE PETITIONS/APPLICATIONS/COMPLAINTS ETC DISPOSED OF OUT OF TURN BY EACH BENCH OF CENTRAL INFORMATION COMMISSION."**

4. The same was forwarded by the CPIO of the RTI Cell to the respective Registries for furnishing the information and in response to the same, Sh. H.P. Sen, Sh. S.C. Sharma, Sh. A.K. Assija, Sh. T.K. Mohapatra, and Sh. S.S. Rohilla, have sent their replies mentioning that no such information/record as sought for by the Appellant is available with them except Sh. S.S. Rohilla who has mentioned that as per the data available in the Registry, total number of non-compliance cases are 300 and no data is maintained for disposal of cases out of turn.
5. The Appellant, being dissatisfied with the response received from the above mentioned CPIOs has filed the present Appeal before the First Appellate Authority on the ground that the information provided is incomplete/misleading or false or no information has been provided at all.
6. I have gone through the contents of the information sought for by the Appellant in his RTI application viz-a-viz, the replies sent by the CPIOs and the written submission dated 10/02/2019 made by the Appellant and I am of the view that the respective CPIOs should have taken the assistance from the office of the Joint Secretary (M&R) to gather the information, if available with him instead of simply informing the Appellant that no information/data is available with them.
7. Therefore, the respective CPIOs are directed to revisit the matter and seek the assistance from the office of the JS (M&R) and provide the same to the Appellant within 15 days from the date of receipt of this order and incase no information is available with the office of the JS (M&R), the Appellant may be informed appropriately.

Hence, the above mentioned Appeals are disposed of.

Sh. Jasbir Singh Arora is further informed that he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
