1. I have gone through the RTI application dated 21/06/2019 filed by Sh. Jasbir Singh Arora and the reply dated 15/07/2019 of Sh. H.P. Sen, CPIO in response to the said RTI application as well as through the First Appeal filed by Sh. Jasbir Singh Arora wherein he has mentioned that the details sought by him were no provided by the CPIO and grounds of the Appeal were 'refusal to access information requested'. I had also gone through the written submission dated 01/08/2019 made by Sh. Jasbir Singh Arora.

2. The Appellant as well as the CPIO were also heard at length. The Appellant was seeking certified copies of notings and correspondence side of the files in which his two e-mails were dealt. He has also provided the details of the e-mails in his RTI application. The CPIO should have located the records to provide the information sought for instead of sending a reply dated 15/07/2019.

3. The CPIO is therefore directed to make efforts to locate the records of dealing with the two e-mails mentioned by Sh. Arora in his RTI application and provide him the certified copies of notings and correspondence side, if available, within 15 days from the date of receipt of this order. It is further directed, if the desired information could not be located after seeking assistance from the concerned officials of the Commission, the Appellant may be informed accordingly. This Appeal is accordingly disposed of.



Sh. Jasbir Singh Arora is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
