1. The RTI application dated 06/07/2019 filed by Appellant Sh. Ashutosh Gautam, reply of Sh. T.B.J.S. Rajappa, CPIO dated 24/07/2019 as well as the First Appeal dated 30/07/2019 filed by Appellant were perused by the undersigned.
2. The Appellant in his First Appeal made the grounds of the Appeal 'details of information not provided or provided incomplete, misleading or false information. After going through the above mentioned records of the First Appeal and the submission made by Sh. Rajappa, CPIO during hearing of the Appeal, I am fully satisfied with the reply sent by the CPIO to the Appellant. Whatever information was provided to him by the Joint Secy. (Admin.) on seeking his assistance under Section 5(4) of the RTI Act, 2005, the same has been provided to the Appellant.

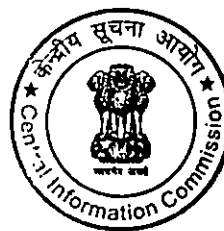
