#### Brief fact:

The Appellant sought the following information vide his RTI application dated 18/07/2019:

- 1. Action taken and date of action taken on communication dated 16/07/2019 vide diary number 645846 w.r.t dak received on 17/07/2019.
- 2. Certified copy of document received on 08/07/2019 and diarised vide number 644925. Reasons for urgency (edited/updated text of RTI appeal INBRU/A/2017/60013 dated 16/08/2017 pending with Intelligence Bureau.

## Record of proceedings:

- 1. The RTI application dated 18/07/2019, filed by Appellant Sh. Praveen Poddar, reply of Sh. S.C. Sharma, CPIO dated 29/07/2019 as well as the First Appeal dated 31/07/2019 filed by Appellant were perused by the undersigned.
- On perusal of the above mentioned records, First Appeal and the submission made by the CPIO during hearing, it has been noticed that no new grounds of First Appeal have been made by the Appellant in his First Appeal except mentioning that the details are not provided and no response within the time limit was provided by the CPIO. He has raised certain issues on the pretext of grounds of the First Appeal which have nothing to do with the information to be provided by the



CPIO. The CPIO has provided the information as sought by the Appellant vide his letter dated 29/07/2019 clearly mentioning therein that:

- "1. The matter was heard in case no. CIC/SERLK/A/2017/609166 and case no. CIC/NFRLG/A/2017/608408 on 12.07.2019, therefore no action has been taken on your mail dated 16.07.2019. As per the available record you were absent during the hearing. However, as per CIC order, one case i.e. Case No. CIC/SERLK/A/2017/609166 has been adjourned and the next date of hearing is being scheduled and you may represent your case at the time of hearing in this case. Dak receipt/link with diary No. 644925 was placed in the file during the hearing.
- 2. Certified copy of document diarized vide number 644925 date 08.07.2019 is enclosed."

...which clearly shows that no information has been hidden by the CPIO and as such the Appeal filed by the Appellant is merely with the intent to waste the time of the authorities of the Commission and also to maline the image of the authority.

3. Therefore, I am of the considered view that the Appeal filed by the Appellant has no merits at all and liable to be dismissed. Hence, the Appeal is disposed of accordingly.

Sh. Praveen Poddar is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.


