Brief facts:

The Appellant has sought the following information vide his RTI application dated 05/07/2019:

1. To provide him the certified copies of the findings, investigations and replies of the TEP respondents in the case No. CIC/CCAKP/A/2018/144420.

Record of proceedings:

1. The RTI application dated 05/07/2019, filed by Appellant Sh. Saurabh Singh, reply of Sh. K.L. Das, CPIO & Dy. Registrar [IC(BJ)] dated 01/08/2019 as well as the First Appeal dated 04/08/2019 filed by Appellant were perused by the undersigned.

2. Sh. K.L Das, concerned CPIO sent a reply on 01/08/2019 to the Appellant informing him that "No such findings, investigation report are available in the file. The



case has been registered during July, 2018 and is pending for hearing. It is therefore not possible for the undersigned to forward the desired documents."

3. Being dissatisfied with the reply sent by the CPIO, the Appellant filed a First Appeal on the grounds 'refused access to information'.

4. The Appellant, during hearing of the Appeal has made a similar request that he may kindly be provided with the certified copies of the documents sought by him vide his RTI application dated 05/07/2019. The Appellant was informed that since the said documents are not with the CPIO, it is not possible for the CPIO to provide him the copies of the same.

5. I am fully satisfied with the reply sent by the CPIO to the Appellant and this matter needs no further intervention of the undersigned. The Appeal is disposed off accordingly.

Sh. Saurabh Singh is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
