Brief facts:

1. Sh. R. R. Tripathy, the Appellant sought the following information vide his RTI application dated 13/08/2019:

- i. Total number of cases fixed for hearing before IC - Sh. Divya Prakash Sinha on 05/08/2019.
- ii. Total number of case heard on 05/08/2019.
- iii. Date on which decisions for the cases heard on 05/08/2019 were uploaded on the website of the CIC.

2. Sh. H.P. Sen, the concerned CPIO vide his letter dated 20/08/2019, responded to the RTI application and gave point-wise reply as follows:

- i. Total no. of cases were fixed for hearing on 05/08/2019 : 13
- ii. Total no. of case heard : 12
- iii. Date of uploading : in between August 5 and 8, 2019.



3. Being dissatisfied with the reply of the CPIO, the Appellant filed First Appeal dated 28/08/2019 before the First Appellate Authority, mentioning therein that details not provided, provided incomplete, misleading or false information. The Appellant has also submitted that the PIO is providing misleading and false information for Sl. No. 1 to Sl. No. 3 and has referred decision dated 05/08/2019 uploaded on 13/08/2019 for the appellant/complainant Shri Varun Krishna uploaded on CIC's website and also attached the same with his First Appeal.

Record of proceedings:

1. Sh. R.R. Tripathy did not appear for the hearing. However, Sh. H.P. Sen, concerned CPIO and Sh. T.B.J.S. Rajappa, Nodal CPIO (RTI Cell) were present during the hearing of the case.

2. On perusal of the RTI application, reply of the CPIO and the First Appeal filed by the Appellant it has been observed that the CPIO has provided the complete information as desired by the Appellant in his RTI application.

3. In the First Appeal filed by the Appellant, he has mentioned the grounds of Appeal as provided incomplete, misleading or false information and also attached his submission dated 28/08/2019 referring therein a decision of the Commission dated 05/08/2019 which was uploaded on 13/08/2019 on the CIC's website and sought for personal hearing to expose the double standards of the PIO. The Appellant was afforded an opportunity to attend the hearing on 20/09/2019 but neither he attended the hearing nor responded to the notice of hearing sent to him for attending the hearing. As per the records available in the file and the copy of the decision dated 05/08/2019 as mentioned by the Appellant, the CPIO has nothing to do with the same as the CPIO has clearly mentioned in his reply to the RTI application that total number of cases fixed for hearing on 05/08/2019 is 13 out of which 12 cases were heard and the decisions of those 12 cases were uploaded between 5th and 8th August 2019.

4. The CPIO has rightly provided the information available with him and he is under no legal obligation to generate any information or the information which is not available with him as desired by the Appellant. Hence, the Appeal is dismissed being devoid of merits.

Sh. R.R. Tripathy is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
