Brief facts:

1. Sh. Jasbir Singh Arora, Appellant vide his RTI application dated 31/08/2019 sought the following information from Sh. H. P. Sen, DR to IC (DP) & the concerned CPIO, mentioning therein that:

- i. Supply the total list of decisions uploaded in respect of information seeker which includes decision dated 27/06/2016 in F. No. CIC/YA/A/2016/90414.


2. Sh. H.P. Sen, the concerned CPIO vide his reply dated 06/09/2019 informed the Appellant that the Registry has heard 5 cases of the Appellant by 06/09/2019. Final decision vide case F. No. CIC/YA/A/2016/900414 was uploaded on 06/02/2018.

3. The Appellant being dissatisfied with the reply sent by the CPIO, file First Appeal dated 07/09/2019 on the grounds that details not provided or refused access to information requested. He has further mentioned that it may be seen from the list of total old and new decisions, the order uploaded on 29/06/2016 in F. No. CIC/YA/A/2016/900414 is being shown as main decision uploaded on 06/09/2018 at Sl. No. 1 of the list. Also from the list of old decisions, it is shown that one decision in F. No. CIC/YA/A/2016/900414 was uploaded on 29/06/2016 at Sl. No. 12 of the list. Whereas, from the list of new decisions uploaded, the main decision was uploaded on 06/02/2018. In view of the above, the Appellant has requested that the CPIO may be directed to provide the correct list of total old and new decisions uploaded consisting of 66 entries instead of only 65 entries.

4. On perusal of the RTI application, reply of the CPIO and the First Appeal filed by the Appellant, it appears that the submissions made by the Appellant has some justification and therefore Sh. H.P. Sen, the concerned CPIO is directed to revisit the earlier information and provide a correct list of total old and new decisions uploaded consisting of 66 entries after seeking assistance from all concerned and in case he finds entry of 65 cases only, the justification of the same be provided to the Appellant within a period of two months from the date of receipt of this order. Hence, the Appeal is disposed of accordingly.



Sh. Jasbir Singh Arora is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.




