

**Brief facts:**

1. Sh. Jasbir Singh Arora, Appellant vide his RTI application dated 31/08/2019, requested Sh. H. P. Sen, DR to IC (DP) & the concerned CPIO to provide a list of those complaints which have been heard out of turn as mentioned in his RTI application.
2. Sh. H.P. Sen, CPIO vide his letter dated 06/09/2019 informed the Appellant that the concerned Registry had heard 11 cases and one complaint out of turn by that day. One more case has been scheduled for out of turn hearing. A list containing 13 case file nos. was also provided to the Appellant.
3. The Appellant, filed a First Appeal against the said information provided by the CPIO on the grounds that the details not provided, refused access to information sought and also mentioned that the CPIO has not provided correct list of total complaints disposed of which are junior to one complaint of the Appellant of 2016. He has further requested that the CPIO be directed to provide the correct list of total complaints disposed of which are junior to the said complaint of the Appellant.
4. On perusal of the RTI application, reply of the CPIO and the First Appeal filed by the Appellant, it appears that the submissions made by the Appellant in his First Appeal has some substance as no complaint of 2016 shown in the list provided by the CPIO which has been heard by the Commission till 06/09/2019.
5. Sh. H.P. Sen, CPIO is therefore directed to go through the records once again and provide the desired information to the Appellant, if available the CPIO and after seeking assistance from all concerned, if he desires to do so, within a period of two months from the date of receipt of this order. Hence, the Appeal is disposed of accordingly.



Sh. Jasbir Singh Arora is further informed if he is not satisfied with the order of the undersigned, he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Hon'ble Information Commissioner Sh. Divya Prakash Sinha at the above mentioned address within a period of 90 days from the date of receipt of this order.
