

Brief facts of the case:-

1. Shri Nirupam Raha, Appellant vide his RTI application sought information on 5 points related to compliance and Non-compliance in respect of case No. CIC/ECRHJ/A/2017/608674.

Reply of CPIO:-

2. Sh. S. C. Sharma, CPIO replied for point No. 1, 2, 3 and 5 on 10.12.2019 with enclosure (correspondence received from CPIO of concerned Public Authority and the letter regarding action taken by the Commission for compliance of the order), Sh. Krishan Avtar Talwar, CPIO replied for point No. 4 of the RTI application on 12.12.2019 stating process of filing of Non-compliance.

Hearing of the Appeal

3. The Hearing Notice was issued for the matter on 19.12.2019 and the matter is heard on scheduled date and time, i.e. on 30.12.2019 by First Appellate Authority. During the hearing CPIOs Sh. S. C. Sharma, Sh. Krishan Avtarl Talwar and Sh. T.B.J.S. Rajappa were physically present while appellant Sh. Nirupam Raha was absent, so the matter was discussed with appellant on his mobile No. 9431337704.

Decision with reasons:-

- 4. During the hearing appellant said that Sh. S. C. Sharma, CPIO in his online reply for point No 1, 2, 3 and 5 stated that 'copy enclosed' but no attachment was found. In this contest Sh. Sh. S. C. Sharma, CPIO submitted that the quantity of enclosure is more than the limit of uploading capacity, so that the same matter (reply with enclosure) was also sent through post, therefore no further intervention is required on the part of the FAA, in the matter.
- 5. The appeal is being disposed of accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
