### Brief facts of the case:-

1. In the RTI application, appellant has sought certified copy of quarter-wise data of all quarters of year 1016-17, 2017-18 and 2018-19 of Annual Report uploaded on the website of Central Information Commission by Central Information Commission in capacity of Public Authority under Section 25 of the RTI Act and online payment link for making payment for getting certified copy.

### Reply of CPIO:-

2. CPIO, Sh. Jeevan Chandra replied vide letter dated 21.11.2019 stating that *“information desired is not readily available with the Commission. However, data of annual returns submitted by the Public Authorities are available on the Central Information Commission website [www.cic.gov.in](http://www.cic.gov.in) under section Annual Report.”*

### Hearing of the Appeal

3. Appellant has been heard by FAA on 23.12.2019 over Mobile No. 7895193159 provided by appellant in Appeal application.

4. Sh. Jeevan Chandra, CPIO has mentioned in his written statement that "RTI cell of the Central Information Commission is maintaining the quarterly returns data of the Central Information Commission as Public Authority. The quarter wise data for the year 2016-17, 2017-18 and 2018-19 which already submitted by the RTI Cell of the Central Information Commission vide their letter No. CICOM/R/2019/50483 dt. 15.07.2019 in capacity of Public Authority may please be referred for information as desired vide your RTI application Regn. No. CICOM/R/2019/50867 dated 30.10.2019."

5. Appellant has also mentioned in his appeal petition that "same information was provided by CPIO Sh. T. B. J. S. Rajappa in supra RTI response dated 15.07.2019. The only difference is that this time in current RTI application I sought certified copy of the same documents which were provided by CPIO Sh. T. B. J. S. Rajappa".

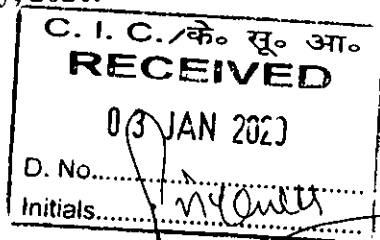
**Decision with reasons:-**

4. On perusal of the Appeal, RTI application, CPIO's replies, available documents with case file and hearing, it is observed that CPIO Sh. T. B. J. S. Rajappa vide his letter No. CICOM/R/2019/50867 dated 26.12.2019 has already provided the certified copy of desired information, **therefore no further intervention is required on the part of the FAA, in the matter.**

5. The appeal is being disposed of accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
