Brief facts of the case:-

In the RTI application, appellant has sought the information:-

"In file no. CIC/BANHU/A/2018/622286, Saurabh Tiwari Vs.CPIO, Admin. & Teaching/Nodal officer, Information Commissioner Vanaja N. Sarna passed an order on 17 October 2019 and took serious note & express extreme displeasure at the then CPIO, Manoj Kumar Gupta. Commission sought explanation from then CPIO Manoj Kumar Gupta within 15 days from the receipt of Commission order for not providing information to Saurabh Tiwari/Applicant even after receipt of Rs. 20 Photocopy charges. But Sh. Manoj Kumar Gupta not provided his explanation to the Central information Commission as yet. A.K. Assija, Deputy Registrar to IC (VN) sent a letter to BHU administration on 13 November 2019 & sought explanation & compliance report from BHU administration within 10 days regarding above mentioned case. In view of above mentioned fact & A.K. Assija letter to BHU administration is attached as PDF file as supporting document with this RTI online application. Kindly provide copy of explanation given by Sh. Manoj Kumar Gupta to the Central Information Commission regarding above mentioned case. What disciplinary action taken & penalty imposed on Sh. Manoj Kumar Gupta for not complying with the Information Commissioner above mentioned order & violating RTI Act provide copy of such order".

2. Reply by CPIO :-

"A Copy of the explanation furnished by Sh. Manoj Kumar Gupta, Asst Registrar (Admn Teaching) and the then CPIO, Sir Sundarlal Hospital, BHU vide communication No. AR(T)/2019/2425 dated 28.11.2019 is attached. No action has been taken".

CPIO, Sh A.K. Asijja replied vide letter No. CICOM/R/2019/50960 dated 09.01.2020 mentioned that :-

"In this connection, it is submitted that the same applicant Sh Saurabh Tiwari, with reference to his RTI application No. CICOM/R/2019/50960.

Appellant had filed first appeal No. CICOM/A/2019/60229 with reference to RTI No. 50890. FAA has order passed order dated 10.12.2019. In Compliance of the said Order required documents were furnished vide CPIO letter dated 17.12.2019. In the said letter it was mentioned that he had sought similar information / documents in RTI No. 50960 also. A copy of the CPIO letter dated 17.12.2019, referred to above is attached. Since the applicant has sought similar documents in RTI application No. 50960, we may send the documents already sent vide letter dated 17.12.2019 again".

Decision

- It is observed that point wise replies provided by Sh A.K.Assija, CPIO is factual 5. and appropriate and no further intervention is required on the part of the FAA, in the matter.
- The appeal is being disposed of accordingly. 6.
- In case the appellant is aggrieved by the decision, he is free to file second 7. appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
