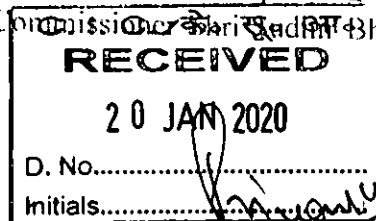
Brief Facts of the case:-

1. In the RTI application, appellant has sought the following information:-
 - a) Kindly furnish the Current Status of a Case registered with File No. CIC/SCOFI/C/2019/655559, dated 01.11.2019 on before the Central Information Commission.
 - b) Kindly furnish the Current Status of a Case registered with File No. CIC/SCOFI/A/2019/660225, dated 24.12.2019 on before Central Information Commission.
 - c) What is the next procedures after getting registered of a Case on before the Central Information Commission?
 - d) Kindly furnish whether any further required procedures need to processed by me against such filled cases.
 - e) Kindly suggest to applicant, whether he may reach to a Court with this cases under the CPC.
 - f) Kindly furnish to how any CIC registered cases can be bring up on before the Hon'ble Court.

Reply of CPIO:-

2. The online information dated 02.01.2020, provided by Sh. S. S. Rohilla, as under:

"Your second appeal No. CIC/SCOFI/A/2019/660225 and Complaint No. CIC/SCOFI/C/2019/655559 are pending for hearing / disposal in the Registry of Chief Information Commission, Shri S. S. Rohilla, Bhargava. The Appeals/Complaints are taken up for



hearing in their own turn. The Commission endeavours to dispose the appeals/Complaints as soon as possible but due to large number of intake, a longer time for their disposal is required. These are disposed on the basis of first come first served. Any further information relating to your appeal as mentioned above can also be obtained from the website of the Commission i.e., <http://cic.gov.in>

Ground of First Appeal:-

3. Aggrieved with reply of CPIO. Sh. S. S. Rohilla, appellant filed the First Appeal stated that "Kindly Trial with a RTI Application No-CICOM/R/2019/51026, dated 30.12.2019, were filled by an applicant seeking for an information from the authorities on numbering wise separately has not been furnish the each required information. Hence this appeal is filled against the above mentioned RTI Application."

Comments of CPIO on First Appeal:

4. For Disposal of First Appeal written comments of CPIO were asked by the FAA. The CPIO in his comments has submitted, "The appellant vide his RTI application (Received in the registry on 30.12.2019) sought latest status of his 2nd appeal & Complaint No. CIC/SCOFI/A/2019/660225 and CIC/SCOFI/C/2019/655559. He further asked for some suggestions and procedure.

5. A reply dated 02.01.2020 was given online informing that appeal & complaint are pending in the registry of Hon'ble CIC. Since CPIO is not supposed to give suggestion/opinion etc. that part was untouched."

Hearing of Appeal:-

6. The hearing was scheduled on 20.01.2020 at 10.00 A.M. and a notice for the same was issued on 06.01.2020 to both the parties. But despite the notice, neither the appellant appeared for hearing nor has he given any telephone number. However, the CPIO, Sh. S. S. Rohilla was appeared before the FAA and presented his case.


Decision with reasons:-

7. On perusal of the Appeal, RTI application and CPIO's reply, it is observed that the reply given by the CPIO is factual and as per provision of the RTI Act, 2005. Therefore, further intervention is not required on the part of the FAA. in the matter.

8. The appeal is being disposed of accordingly.

9. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi - 110 067 against this order within 90 days.
