2. Reply by CPIO :-

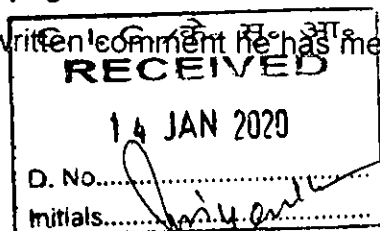

3. RTI applicant filed First Appeal as under :-

"My diary no 654092 tell me the contact info of registrar who observe my case and commissioner name when will be my case hear by commissioner tell me date of my hearing."

Comments of CPIO:

4. For disposal of First Appeal written comments of CPIO were asked by FAA and CPIO, Sh. A K. Assija given his comment vide letter No. CICOM/A/E/20/00003 dated 13.01.2020, in his written comment he has mentioned that:-

"In his RTI application, the appellant had sought information about the date of hearing and status of his second appeal filed vide diary No. 654092 and detail about the judge who would hear his case. In reply, the CPIO has informed the appellant that the hearing of the case bearing diary No. 654092 (allotted File No. CIC/NCHMT/A/2019/654092) will be fixed for hearing in chronological order due course. Further, as on the said date cases registered in July, 2018 were being fixed for hearing in the Registry of IC (VN). The registry is unable to provide the exact date of hearing to the appellant as also the name of the IC, who would hear the case, in view of re-allocation of cases to ICs from time to time".

Hearing of the Appeal

5. Appellant has been heard by FAA on 06.1.2020 over Mobile No. 9981725376 provided by appellant in Appeal application.

Decision

6. It is observed that the information provided by Sh A.K.Assija, CPIO is factual and appropriate, therefore no further intervention is required on the part of the FAA, in the matter.

7. The appeal is being disposed of accordingly.

8. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
