Brief Facts of the case:-

1. In the online RTI application, appellant, by referring Office Memorandum No. 1/6/2011-IR dated 15.04.2013 (Subject: Implementation of Suo motu Disclosure under Section 4 of RTI Act, 2005) and the Second Appeal Order No. CIC/SA/A/2014/000024, CIC/SA/A/2014/000251 & CIC/SA/A/2014/000018 dated 05.12.2014, in the matter of Mr. R. K. Jain Vs. Department of Legal Affairs, Govt. of India, under which directions were issued to the public authorities to implement the above guidelines issued by the DOPT and upload the RTI questions and responses, first appeals, FAA order, Second appeals, CIC orders and compliance on the website, asked for following documents and information:-

5. The first appeal was heard on 21.01.2020 over mobile No. 7895193159 of the appellant.

6. On perusal of the Appeal, RTI application, CPIO's reply and hearing, it is observed that appropriate reply has not been furnished by the CPIO to the appellant. Therefore, Sh. Jeewan Chandra, CPIO, M&R Section is hereby directed to revisit the information asked for by the appellant and send an appropriate reply to appellant within 14 days after receipt of this order
