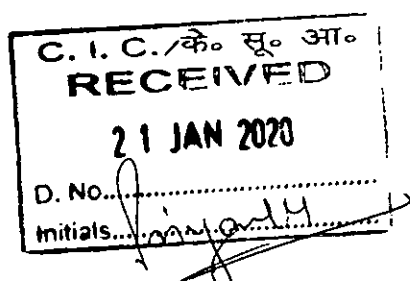
Appeal file no. CIC/SG/A/2011/001307 is also not available in the digital form in the APPCOM System of the Commission, as such information can not be provided".

Ground of First Appeal:

3. Aggrieved with reply of CPIO, Sh. R. P. Grover, appellant filed the First Appeal requested for hearing.

4. For disposal of First Appeal written comments of CPIO were asked by FAA, but no comments have so far been received from him.

Hearing of the Appeal:

5. For disposal of the appeal, appellant has been contacted over Mobile No. 9810639996 provided by appellant in Appeal application and heard the matter on 21.01.2020.

Decision with reasons:-

6. On perusal of the Appeal, RTI application and CPIO's reply and hearing, it is observed that the information provided by the CPIO, Sh. R. P. Grover is as per available records. However, **direction is given to CPIO, Sh. R. P. Grover to revisit the matter and try to find the concern case file and intimate the appellant accordingly within 10 days of receipt of this order.**

7. The appeal is being disposed of accordingly.

8. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.


